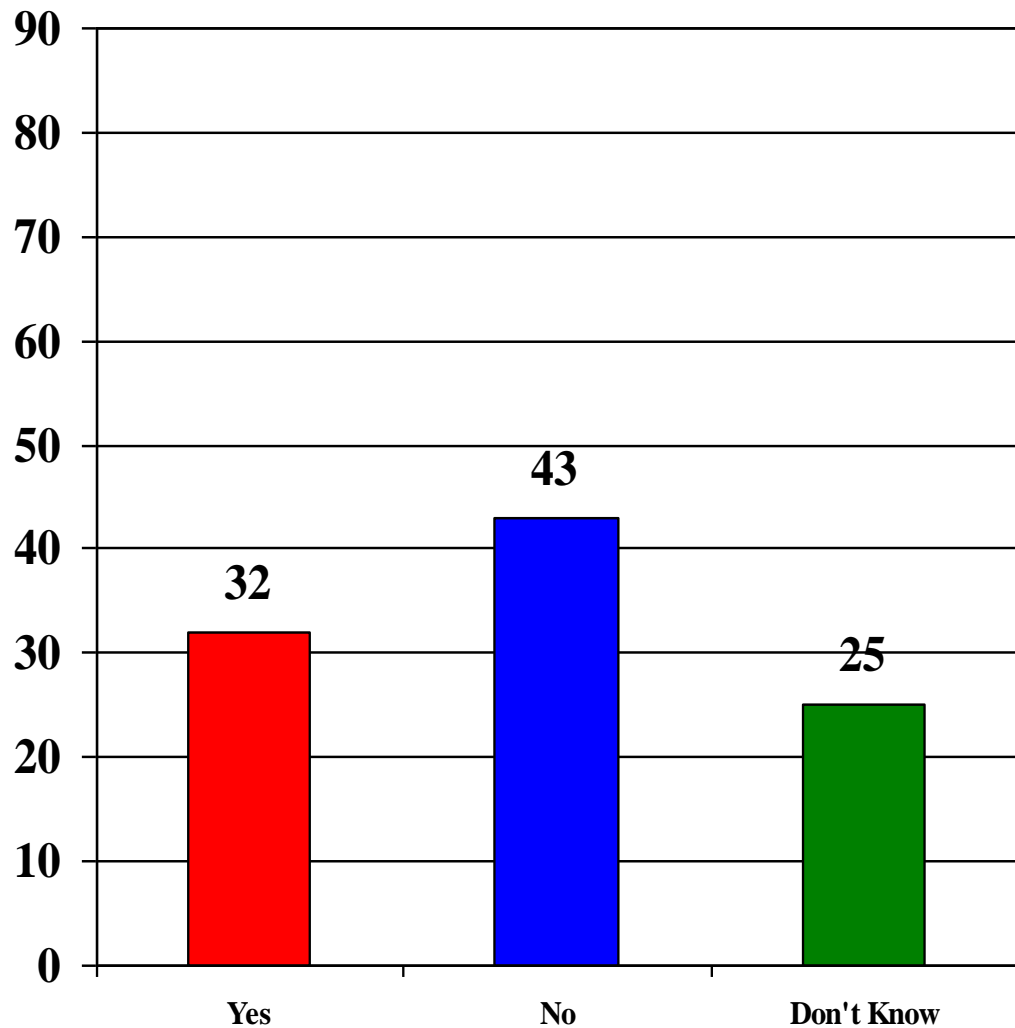
During the recent protests in Charlottesville, there were left-wing protesters from a group called ANTIFA.

Given that ANTIFA advocates violence as the appropriate response to free speech they disagree with, do you support or oppose ANTIFA?



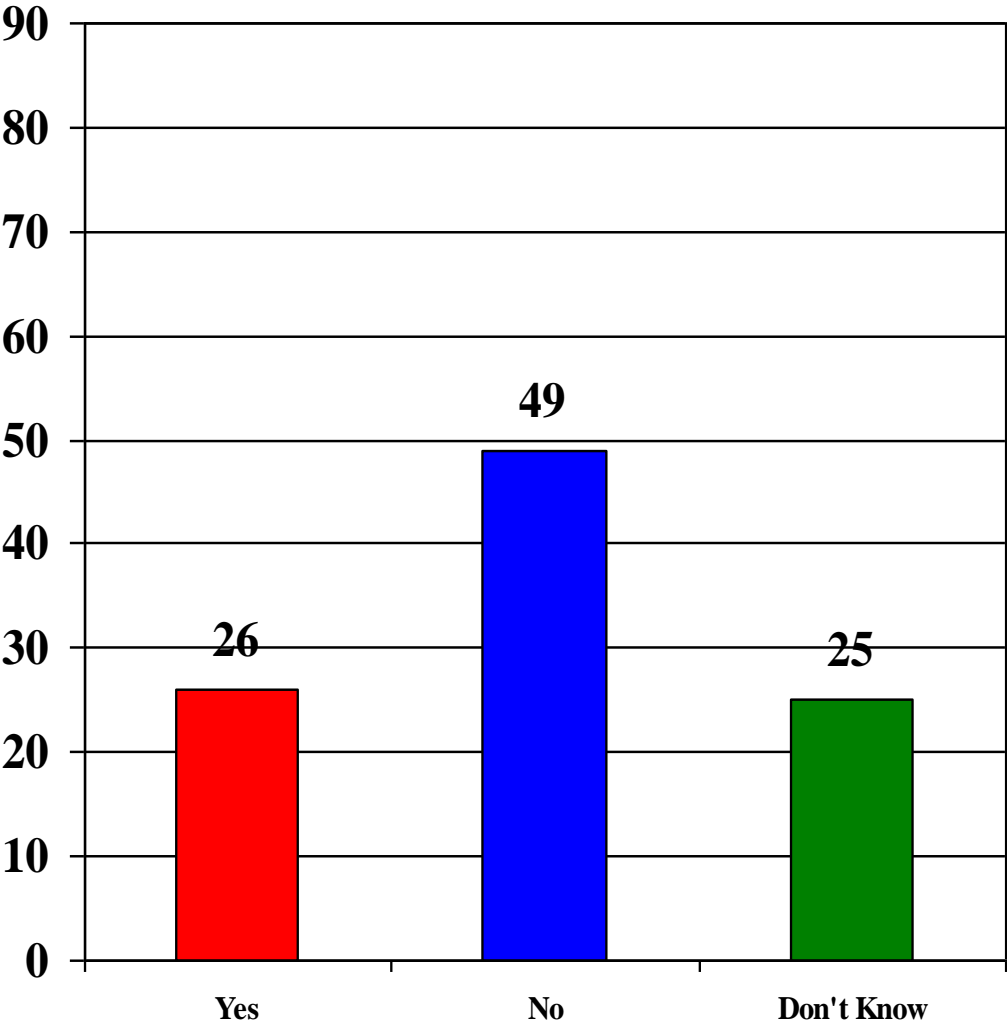
